### 01

The offline venue does not use paper, the conference manual and materials are shared by scanning the code, the conference tea break will provide carbon neutral coffee and tea bags.

#### 02

Invite carbon exchange to the conference venue, all attendees (including foreign guests and on-site attendees) will get their emission reductions traded at the conference site through Alipay.

### 03

All offline attendees and visitors use the Carbon Footprint software two weeks in advance and are encouraged to accumulate personal emission reductions through cycling, public transportation and online trading.


#### 04
