- Obtaining free professional advice on enhancing effectiveness of environmental initiatives from the technical consultant of the programme.
- Enhancing corporate competitiveness, encouraging businesses in the same sector to improve their operations and be more concerned about the environment.
- Winning organisations may gain media coverage opportunity or be invited to public events to showcase and share their environmental achievements and experiences.
- Receiving a trophy / certificate for display at prominent places in the organisations to allow the public to know more about their environmental commitment and contribution.

Assessment Criteria



Level of Innovation

- Existence of innovative elements
- Degree of originality

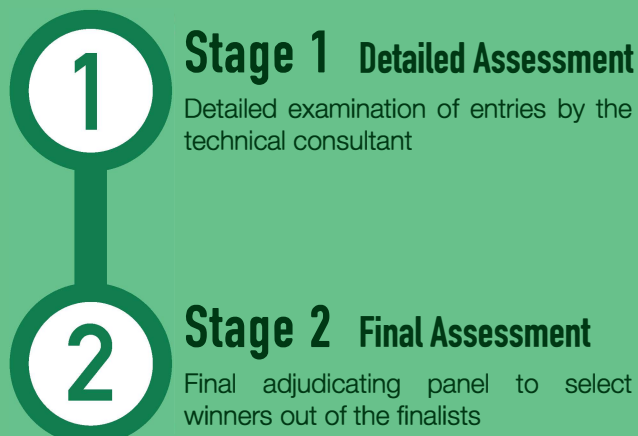
Environmental Achievements and Cost-effectiveness

- Degree of measurable improvement to the environment
- Ability to generate benefits to multiple environmental aspects
- Number of accreditations or external stakeholder acknowledgements
- Level of cost-effectiveness

Practicability and Contribution to Society

- Extent of potential application to meet broader needs
- Amount of efforts in creating awareness amongst the business community or general public

Assessment Process
