The Environmental Division Committee began the 2012/2013 financial year with a balance of HK\$420,812.65 and received a total allocation of HK\$111,913.00 from the HKIE Headquarters. The Division's account held a total of HK\$341,749.51 at the end of March 2013. According to the Rules for Division Accounts, after the Division has

received its "End of Year Account" for the 2012/2013 financial year from the HKIE Headquarters, two assigned Corporate Members will audit the account. After the audit, the account will be available for inspection.

Activities

In addition to organizing high quality technical meetings and visits, in this session we are actively involving in other activities, such as attending and responding to consultations, receiving overseas delegation, making presentations to professionals and general public, and representing HKIE on external committees / panel so as to further boost up the professional standing of HKIE Environmental Division. The activities organized / participated by the Committee are summarized in the **Annex** of the report. Some signature activities of this session are highlighted below:

The Annual Reception was held on 21 September 2012 at Zero Carbon Building with Mr. K. S. Wong, the Secretary for Environment as the Guest of Honour. This is the first HKIE activity that was arranged in the first and newly built "zero carbon" building in Hong Kong. There were over 150 participants attending the reception to share their experience and views on environmental issues in a casual and "low carbon" atmosphere.

With the concerted efforts of the HKIE headquarters and other divisions, we have participated in the organization of the Guangzhou/Hong Kong/Macau/Taiwan Forum in Hong Kong on 23-24 November 2012, and the Sustainable Development Forum in Macao on 7-8 December 2012. Around 400 participants from Hong Kong, Mainland China and Taiwan exchanged their views and expertise in these 2 high level regional events.

The Forum on Challenges and Opportunities with Food Waste Management was held on 6 December 2012 at HKPC Building with Mr. K. S. Wong, the Secretary for Environment as the Guest of Honour who delivered a keynote speech on government's strategies towards effective food waste management. There were 9 other speakers (of which 7 of them are from Germany, Korea, Japan, Mainland China and Taiwan) sharing their expertise on food waste policy, technologies and management aspects with over 200 participants.

To celebrate the 25th anniversary of the Environmental Division, a celebration dinner was held on 18 March 2013 at Craigengower Cricket Club with Ms Anissa Wong, the Permanent Secretary for the Environment / Director for Environmental Protection as the Guest of Honour. At the celebration, the prizes of the 1st Young Green Leader Award organized by the Environmental Division were also presented. About 150 guests attended this function.

The Annual Seminar titled as "Green Building and Construction Materials – Challenges for Innovation and Excellence" was held at Theatre II of the Hong Kong Convention and Exhibition Centre on 22 March 2013. Ir Prof. K. K. Choy, the President of the HKIE presented the Opening Address while Mr. K. S. Wong, the Secretary for the Environment and Ir the Hon Dr. W. K. Lo, Member (Engineering Functional Constituency) of the Legislative Council delivered Keynote Addresses. The one-day seminar was well received with over 300 participants.

We have organized our biannual Environmental Paper Award in this session with the theme of Green Building Development. We have received a total of 8 high quality papers from government, utilities, consultants & academia.

We have organized a professional course on Waste and Environmental Management from April to June 2013, aiming to provide the updated knowledge for those who wish to pursue their careers in the direction of waste and environmental management and pollution control, and for industry professionals who need to formulate company environmental policy or improve the environmental performance of their companies.

We are actively planning for a study mission to Korea in April 2013 with the objective of learning the latest waste management practices and technologies in Korea, which we hope to bring in new insights and practices for tackling Hong Kong's waste management problems.

We have organized the first Job Shadowing Programme in this Session, with the participation of over 50 students from 6 secondary schools. With the support from three host organizations/companies, namely CLP Power Limited, Environmental Protection Department and Hong Kong Productivity Council, the programme helped young people explore first-hand skills needed to succeed in today's and future job markets and enhances their environmental awareness, contributing to the sustainable development of the city.

Environmental Discipline Advisory Panel

This was a fruitful year for the Discipline Advisory Panel (DAP) in terms of membership which grew to 275. The panel held four meetings in this session. Apart from processing various qualification and training matters and degree programmes accreditation, the panel also worked on several key issues including:

- Securing the endorsement of Q&M Board on making the Special Route (formerly known as Emerging Discipline Route) for Environmental Discipline a permanent arrangement;
- Contributing to the HKIE Working Group on the Implementation of Competence Based Approach in Assessment of Experience and Professional Competence; and
- Working on the accreditation of the new 3-3-4 engineering degree curricula.

To further extend our membership, a proactive membership drive programme was launched with talks given to major corporations including CLP Power HK Ltd., Towngas China Co. Ltd, and MTR Corporation Ltd. The panel also took part in the HKIE InnoCamp 2013 to map out the strategies for enhancing the professional image of engineers.
