# **Publication in HKIE Monthly Journal**

We continue to act as a coordinator which works closely with potential writers for preparation of articles related to climate change issues from different perspectives for publication in Climate Change Corner under HKIE monthly journal. By end of end 2016, we submitted 20 articles about the activities / seminars organised by us for sharing and communication among members. Young members are awarded with book prize coupons if their articles are selected for publication.

### **HKIE Environmental Division Website**

The HKIE Environmental website (http://ev.hkie.org.hk/) has performed an excellent function in keeping members up-to-date with major and important events. These include the activities for which we are the supporting organisation. The photos and the PPT files presented in the seminars can be downloaded from the website to facilitate easy sharing useful information. The photo gallery stores photos taken in the current and past activities were unloaded for sharing among members, which brings back wonderful memories and joyful moment in the various event and activities.

## Activities

In addition to organising high quality technical seminars and visits, in this session we also involved in other activities, such as making presentations to professionals and general public, attending and responding to consultations, and representing HKIE on external committees / panels so as to further boost up the professional standing of HKIE Environmental Division. The activities organised and coorganised by the Committee are summarized in the Annex 1 and 2 of the report. Some signature activities of this session are highlighted below:

The Annual Reception was held on 23 October 2015 at Craigengower Cricket Club with Secretary for the Environment, Mr. Wong Kam-sing, JP as the Guest of Honour delivered a speech entitled "Recent Past and Future of Environmental Policies and Programmes in Hong Kong – Opportunities for Strategic Partnership". There were over 120 participants attending the reception.

We organised the Job Shadowing Programme and continue to extend the outreaching from high school to tertiary education students, and thus we received over 70 students from 3 higher education institutions and 1 secondary school attending this Programme. With the support from 4 host organisations/companies, namely CLP Power Hong Kong Ltd., Hong Kong Productivity Council, Hong Kong Electric Co., Ltd. and Hong Kong and China Gas Co., Ltd., the programme provides an opportunity for young people to explore first-hand skills needed to succeed in today's and future job markets and to enhance their environmental awareness. The programme was welcomed by the students, who have expressed strong interest in the environmental engineering profession and they were also able to appreciate the knowledge and ability required to develop their careers as environmental engineers.

The Annual Forum entitled "Hong Kong's Role in Low Carbon Development: Challenges and Way Forward" was held at the Hong Kong Convention and Exhibition Centre on 18 April 2016. It aimed to promote and facilitate the discussion on the low carbon challenges and its way forward in Hong Kong by bringing together various stakeholders including professionals and experts, academics and research institutions, businesses and policy makers. The Forum comprised the keynote session and four other sessions including (1) Climate Resilience and Challenges; (2) Development of Low-Carbon Infrastructure; (3) Urban Mobility; and (4) Carbon Pricing and Market. A technical report for this seminar will be posted on the website of HKIE Environmental Division for sharing among the community at large. To encourage organsing events in an environmentally friendly manner, we have established the Green Event Guideline, which provides guidance on green initiatives when organising an event and on estimation of carbon footprint for offsetting. To promote this guideline, we include this guideline in our website for sharing and downloading and follow its requirements whenever we organise an event such as our Annual Forum.

To echo the 40<sup>th</sup> Anniversary Celebration activities, we are now producing a micomovie, aiming to encourage young generation to become an environmental engineer as their future career.
