memories and joyful moment in the various event and activities, The icon "Facebook", the first of this kind under HKIE, was erected in our website for members to share their thoughts as well.

Finance

The Environmental Division Committee began the 2013/2014 financial year with a balance of HK\$348,095.51 and received a total allocation of HK\$119,383.00 from the HKIE Headquarters. The Division's account held a total of HK\$337,498.70 at the end of March 2014. According to the Rules for Division Accounts, after the Division has received its "End of Year Account" for the 2013/2014 financial year from the HKIE Headquarters, two assigned Corporate Members will audit the account. After the audit, the account will be available for inspection.

Activities

In addition to organizing high quality technical meetings and visits, in this session we are actively involving in other activities, such as attending and responding to consultations, receiving overseas delegation, making presentations to professionals and general public, and representing HKIE on external committees / panel so as to further boost up the professional standing of HKIE Environmental Division. The activities organized / participated by the Committee are summarized in the **Annex** of the report. Some signature activities of this session are highlighted below:

The Annual Reception was held on 11 October 2013 at Craigengower Cricket Club with Mr. LAM Chiu Ying, the ex-Director of Hong Kong Observatory as the Guest of Honour. Ir Dr the Hon LO Wai Kwok, Member (Engineering Functional Constituency) of the Legislative Council gave musical performance at the reception. There were over 120 participants attending the reception to share their experience and views on environmental issues in a casual atmosphere.

In line with the Government's policy on sustainable solid waste management and implementation of a new AQO in 2014, the Division has jointly organized with Hong Kong Waste Management Association and the Institution of Mechanical Engineers – Hong Kong Branch (IMechE-HKB) a conference on 22 November 2013 at Hong Kong Productivity Council with Mr. K. S. Wong, Secretary for the Environment, Ir Raymond Chan, the President of HKIE, Dr Colin Brown, Director of Engineering, Institution of Mechanical Engineers and Ir the Hon Dr. W. K. Lo as the Guests of Honour. Following the conference, the joint organizations with YMC organized Waste Management Seminar Series – Implementation of Waste Charging Scheme in Hong Kong: Go or Not Go on 15 January 2014 and Hong Kong's comprehensive waste management strategy for coming 10 years on 27 February, World Trend in Food waste treatment by Anaerobic Digestion on 3 March 2014 and Waste-to-energy for municipal solid waste treatment on 24 March 2014. The Division together with individual Committee Members also joined the Alliance for promoting sustainable waste management for Hong Kong which was launched on 21 November 2013.

The Annual Seminar titled as "Hong Kong Energy challenges & Solutions" was held at Theatre II of the Hong Kong Convention and Exhibition Centre on 9 April 2014. The seminar was timely organized three weeks after the Government announced the Future Fuel Mix for Electricity Generation Consultation Document regarding planning ahead for a better fuel mix in Hong Kong. At the opening of the seminar, Ir Raymond Chan, the President of the HKIE presented the Opening Address while Mr. K. S. Wong, Secretary for the Environment and Ir the Hon Dr. W. K. Lo, Member (Engineering Functional Constituency) of the Legislative Council delivered Keynote Addresses. The one-day seminar was well received with over 300 participants. A technical report for this seminar will be posted on the website of HKIE Environmental Division for sharing among the community at large.

We arranged a total of eleven site visits for the members to obtain in-depth information about the facilities. We also co-organised with the Hong Kong Environmental Industry Association an overseas study mission to Kawasaki, Japan between 13 and 15 February 2014 on the latest waste management practices and technologies. A debriefing would be organized in June 2014. We would support the HKIE by setting up a booth in its HKIE Fiesta 2014 to be held on 8 June 2014.

The Environmental Project competition was held to stimulate the interest and cultivate a green culture amongst undergraduate students on environmental protection and conservation. Oral presentation of

participants was held on 12 April 2014. The awards would be announced after the 27th Annual General Meeting of the Division, which would be held on 29 April 2014. For secondary school students, we coorganized with Thei an environmental engineering workshop on 12 April 2014. We have also organized the Job Shadowing Programme which helped young people explore first-hand skills needed to succeed in today's and future job markets, enhance their environmental awareness and contribute to the sustainable development of the city. With the support from two host organizations/companies, namely CLP Power Hong Kong Limited and the Hong Kong Jockey Club, over 40 students from 2 secondary schools had taken part in the programme. The programme was welcomed by the students who expressed strong interest in the environmental engineering profession. They recognized the knowledge and ability required to develop their career as environmental engineers in the programme.

Apart from actively participating in the international/two straits and four places conferences, our delegations also presented technical papers in WFEO Energy Conference ESEDC 2013 in Guangzhou and 第 11 屆兩岸四地工程師(澳門)論壇. The one "亞太城市建設實務論壇" will be held in Taiwan in May of this year.
